Transportation Security Administration (TSA)

RTA provides program management support services to support TSA in its Enrollment Services and Vetting Programs, Vetting and Analysis Division, and Mission Schedule and Notification System. Additional details on our programs are included below:

Enrollment Services Vetting Program (ESVP): The purpose of this Call Order is to support TSA's Enrollment Services and Vetting Programs procurement of Program Management Support Services. We support TSA's mission through strategic consulting, management, scientific and technical support services for programs and project initiatives or functions required, authorized or serviced by TSA's Intelligence and Analysis (I&A) Office. The support services are applicable to ESVP projects, functions and initiatives including the support of other key stakeholder offices or entities that support or are supported by an I&A managed program, project or initiative where the use of strategic consulting, management and technical support services is TSA I&A mission-related.

Vetting and Analysis Division (VAD): We are engaged to provide strategic consulting, management, scientific and technical support services for programs, projects, initiatives or functions required, authorized or serviced by TSA's I&A Office. Our support includes a range of I&A consulting functions for ongoing vetting operations and maintenance support including optimization, mission support, reporting, quality control and assurance, training support and transitions.

Mission Schedule and Notification System (MSNS): The scope of this effort includes reviewing TSA's Acquisition Manual to determine all documents and activities required to achieve Acquisition Decision Event 2A, produce those documents, support the required activities, and provide all associated administrative support. We also interface with MITRE to transfer technical knowledge as necessary.

Centers for Medicare & Medicaid Services (CMS)

RTA supports CMS with operations, maintenance and development services for its Multidimensional Information Data Analytics System (MIDAS). This system provides mission-critical functionality for the Center for Consumer Information and Insurance Oversight to implement and enforce statutory requirements for issuers related to the Affordable Care Act.

Through this work, we curate and integrate data from multiple data and operational source systems into a single data platform. Our services include multiple requirement analysis, testing and implementation using Agile methodology. Through pipeline redesign efforts, MIDAS now offers a simpler and more efficient design to take data from the Health Insurance Marketplace and adopt upstream data model changes for an improved customer experience when accessing trusted data, decreasing turnaround time and enabling self-serve analytics.
